





WHAT ARE COMMUNITY HEALTH CENTERS?

Community health centers (CHCs), also known as Federally Qualified Health Centers (FQHCs) or health centers, are non-profit health care providers that deliver comprehensive primary health care services to medically underserved communities. To best serve their patients, many health centers offer a one-stop-shop of integrated services under one roof like medical, dental, behavioral, vision, transportation, case management, and more.

The health center program provides health care to over 30 million individuals in the United States. Health centers have long been a bipartisan solution to concerns about health care access, quality, and cost. Health centers treat all patients regardless of ability to pay. In Oklahoma, where many families and individuals lack access to primary care, health centers provide much-needed cost-effective and preventive services and save the health care system money by preventing expensive, avoidable emergency department visits and chronic illnesses.





OKLAHOMA COMMUNITY HEALTH CENTERS

Community health centers (CHCs), also known as Federally Qualified Health Centers (FQHCs) or health centers, are nonprofit health care providers that deliver comprehensive primary health care services to medically underserved communities. To best serve their patients, CHCs offer a one-stop-shop of integrated services like medical, dental, vision, transportation, case management, behavioral health, substance use disorder services, and more.

The health center program is the largest network of primary care in the country, providing health care to over 30 million Americans including over 330,000 Oklahomans in 2022. For decades, CHCs have been a bipartisan solution to issues concerning health care access, quality, and cost. In Oklahoma, where many families and individuals lack access to primary care, health centers provide much-needed cost-effective primary care that saves the health care system money by preventing expensive, avoidable emergency department visits and chronic illnesses. Twenty-two health centers serve Oklahomans at over 170 sites.

CHCs treat all patients regardless of ability to pay or insurance status. CHCs use sliding fee scales based on patients' income, have after-hours coverage, meet extensive performance and accountability requirements, and are governed by patient-majority boards that reflect the communities they serve.

CHCs are economic engines!

According to a Matrix Global Advisors (MGA) analysis, which quantifies the direct and indirect economic impact of Community Health Centers in Oklahoma, health centers supported 4,869 jobs, \$822.7 million in economic output, and \$362.1 million in labor income in Oklahoma in 2021.

CHCs are efficient!

Studies show Medicaid patients treated in CHCs are 25 percent less likely to seek expensive, avoidable emergency room care than non-CHC Medicaid patients and have lower utilization of other services resulting in 24% less health care spending overall.

CHCs are effective!

Although their patients tend to have low incomes and complex chronic conditions, CHCs consistently deliver top notch results!

CHC patients are more likely to receive primary services like screenings for cancer and depression. CHC patients have lower rates of low birth weight than non-CHC patients.

CHCs drive down health care spending!

Oklahoma health centers participating in the Medicare Shared Savings Program saved \$15 million last year by driving the cost of care by \$1,000 per patient. Since 2019, community health centers in Oklahoma have saved Medicare nearly \$40 million.

Community health centers (CHCs) know good health care starts when individuals and communities take responsibility for their health!

CHCs are non-profits with patient-majority governing boards that know the issues specific to their communities. CHCs are strategically located in areas with low provider-to-population ratios to ensure that all residents have access to services, no matter where they live. In 2022, community health centers in Oklahoma served more than 330,000 patients through over 1,250,000 patient visits.

CHCs are efficient!

Studies show Medicaid patients treated in CHCs are 25 percent less likely to seek expensive, avoidable emergency room care than non-CHC Medicaid patients and have lower utilization of other services resulting in 24% less health care spending overall.

CHCs are effective!

Although their patients are predominantly low income and often have complex chronic conditions, CHCs consistently deliver top notch results! CHC patients are more likely to receive primary services like screenings for cancer and depression. CHC patients have lower rates of low birth weight than non CHC patients.

CHCs are trailblazers!

CHCs have been doing patient-centered primary care for decades! CHCs are private-public partnerships that provide integrated primary, dental, vision, substance abuse, and behavioral health care services alongside interconnected enabling services like transportation, education, and case management.

CHCs are a part of the health care solution!

The CDC reports that chronic diseases account for 7 in 10 deaths in America. By encouraging physical activity, nutrition, and substance abuse cessation, CHCs help patients avoid costly, preventable chronic illnesses that drive up health care spending.


An Answer to Oklahoma's Primary Care Shortage

Community Health Centers target underserved areas and populations and are located in Health Professional Shortage Areas (HPSAs). Seventy-five of Oklahoma's seventy-seven counties are wholly or partially HPSAs.

According to the Association of American Medical Colleges, Oklahoma ranks 45th in the nation in its ratio of physicians per 100,000 people and 44th in its ratio of active primary care physicians per 100,000 people.

Three in five rural Oklahoman doctors are over age 50. The average age of physicians in Oklahoma is 52; the average age of rural physicians in the state is 56. As our physician workforce continues to age, community health centers are situated to address our workforce shortage by recruiting talented professionals to medically underserved parts of Oklahoma.

Health centers use patient-centered health care provider teams to provide comprehensive, integrated care. From receptionists and medical assistants to nurses and doctors, all members of the medical team work together to provide seamless, quality care to their patients.



Why Advocate?

To make significant strides in policy priorities, community members – YOU – must be directly involved just as overall health does not improve if individuals do not strive to improve their own health. Further, while obvious, having representation only works if those elected know how to represent you.

Health centers have moved beyond being the “best kept secret in the health care industry.” However, health centers must be much more proactive, innovative, efficient, vocal, and prominent to become the “health care home” for 30 million individuals in the next few years. Legislators, agency heads, the media and all of the community must be educated about the importance of sustaining these providers such that all people may have access to care.

Consider what is at stake. Everyone wants part of the pie. Moving priority away from your issues when others are pushing theirs is relatively easy when officials do not know much about what you do; decision makers would not necessarily sense a constituent consequence. Policies change based on philosophies, evidence, value, popularity, and perceptions. If only one person calls and makes a reasonable case, that information can become the perceived reality. Further, changing perceptions is difficult. Would you like to be the one to make that call? Do a great job, and then tell everyone about what we collectively accomplish. As health care safety net providers, telling the story is a large part of what ensures that patients get what they need.

Examples of policies that can affect primary care safety net providers:

- Operational authority and appropriations
- Treatment of FQHCs in Medicaid waivers
- Health insurance reform
- State agency / program regulations
- Medicaid eligibility levels and benefits
- Infrastructure support mechanisms

We have designed this guidebook as a resource that can be updated as necessary to aid you, as a health care advocate, to spread the news about the Oklahoma’s health care needs and make recommendations to improve Oklahoma’s health care system. Not only do we want better health outcomes for patients, but we also realize the economic importance of having adequate health care for Oklahomans. Legislators, agency heads, the media, and communities must be educated about the importance of safety net providers so that all people can have access to high quality health care. In the coming months, we plan to call on you to use your advocacy power – together, we can make a difference!

Keys to Health Center Advocacy

Know your facts

Be able to express both your view and that of your opposition accurately. Being viewed as a reliable source of information helps build your credibility and make your voice heard.

Have a plan

Effective advocacy can take time and planning is important. Having an advocacy plan in place can help you and your advocates respond quickly to important issues and be able to convey a single, cohesive message. Be sure your plan includes ongoing advocacy as well as how to mobilize advocates on short notice.

Build relationships with elected officials AND their staff

Get to know who represents your health center at the local, state, and federal levels. Invite them to take a tour of your health center. Learn who works in your U.S. Senators' and Representative's district offices as well as in D.C. and know what issues they work on. Remember that legislative staffs often act as gatekeepers and key resources for information - help them get to know your program and the benefit your health center brings to the community.

Keep the relationships going

Take every opportunity to involve your elected officials in your health center. Keep them informed of changes at the health center: the addition of new services or new facilities, new board members, or special events. Always remember to recognize publicly and thank your elected officials for their support of your health center.

Learn to tell your story

Personal stories are often the most compelling. Learn to tell yours and tell it often. Be able to tell how your health center has benefited you and those you know, share patient stories - or better yet - have them tell their own story.

Communicate Effectively

Know your message and know your audience. Look for understand and for ways to ensure your has been clearly understood as you intended it. Ask and answer questions to address any misunderstandings. Follow-up if possible to provide any additional information you think will be helpful and be sure to respond to any questions.

Be Proactive

Being proactive involves voluntarily reaching out to stakeholders and the media to educate them about the value of health centers and the importance of health care issues. Offering timely and accurate information to stakeholders can help you generate credibility with decision-makers and create a positive relationship with media contacts.

Contacting Your Legislators

Being able to effectively communicate with elected officials is a vital skill for any advocate. Elected officials often rely on information they receive from the public and advocates to help shape how they vote on key issues. Legislators have to weigh many factors in making their decisions and your message could be the one that makes the difference. Work to develop a relationship with your legislators – get to know them and their issues and learn how to communicate your message to them on their terms.

How to Contact Your Legislator

1. Call your legislator. Don't be afraid to call your legislator directly. You can also call local or district offices and speak with staff members who will share your message.
2. Write a letter. One way to contact your legislator is to write a letter. Your letter may be typed or hand-written. Be sure your name and address is clearly written on your letter so your legislator will know you are from the district s/he represents.
3. Use proper protocol. It is important to address your legislators properly in your communication.
4. Send an email. Increased security may mean delays in regular mail so an email can be just as effective as a letter - especially if time is limited. Many legislators have web-forms for email communication. Use these forms to make sure your message gets through.
5. Be brief and to the point. Regardless of the method you use to contact your legislator, it is important to keep your message to the point. Legislators may not have time to read all of a lengthy letter. Be as clear and concise as possible to make sure your message is not lost.
6. Use your own words. Form letters and template messages can be effective, but not as effective as your story. Tell your legislator how the issue you are contacting them about affects you and your community.
7. Remember social media. Many legislators now use social media networks to communicate with constituents. These sites can be an excellent way to keep up with your legislators and let them know how you think they are doing.
8. Thank your lawmaker for his/her time and consideration.

Lobbying Guidelines for Health Centers

Lobbying & Advocacy

Health centers may lobby – they may communicate with their Members of Congress of state or local legislators to influence the passage or defeat of legislation.

However, health centers may not use Federal grant funds to pay for lobbying expenses, including staff time, space costs, telephone costs, postage, photocopying, facsimiles, printing, or travel reimbursements.

Non-grant revenues (including program income) may be used for lobbying if they are not restricted by the source providing the revenue.

Health center staff may lobby on health center time if the part of their time allocable to lobbying is not paid for with federal grant funds and is insubstantial in relation to all of the health center's activities.

Health center staff may lobby on their own time without using health center resources.

Volunteers can lobby for the health center if the use of the health center name is authorized by the board or the CEO.

Lobbying cannot constitute a "substantial part" of a health center's total activities.

If lobbying becomes a "substantial part" of a health center's activities, a health center can lose its 501(c)(3) tax exemption and can be subject to tax penalties.

There is no federal regulation which precisely defines when lobbying activities become "a substantial part" of an organization's activities. At least one court has held that 5% of an organization's time and effort spent on lobbying is not substantial, and some have argued that as much as 15% could be considered to be an insubstantial amount of lobbying.

Political Activity

Health centers cannot make political contributions to candidates or support or oppose candidates for office.

Individual employees or patients of a health center can engage in political activities if they do not use health center resources for that purpose or otherwise associate the health center with a political candidate or campaign (for example, by using the health center's name in speeches or letters).

Oklahoma Legislature

Oklahoma's bicameral Legislature is composed of 48 members of the State Senate and 101 members of the House of Representatives. Regular sessions of the Legislature convene annually at noon on the first Monday in February. Regular sessions must be adjourned by 5 p.m. on the last Friday in May every year. In odd-numbered years, the regular session will also include one day in January.

The Legislature will meet at noon on the first Tuesday after the first Monday in January and will recess no later than five p.m. on the same day to declare elections. Normally, the Legislature is in session Monday through Thursday. Extraordinary sessions may be called by the Governor or by the Legislature itself.


Legislatures are identified by consecutive numbers. For example, the 2021 session was designated as the First Session of the 58th Legislature; the 2022 session as the Second Session of the 58th Legislature; the 2023 session as the First Session, 59th Legislature; and the 2024 session as the Second Session, 59th Legislature.

Each house of the Legislature organizes independently to function during the legislative session. By law, the Lieutenant Governor is president of the Senate, but the role is limited to presiding over special sessions and casting the deciding vote in case of a tie. The law also provides the Senate will elect a President Pro Tempore and the House of Representatives will elect a Speaker of the House. State Senators serve staggered four-year terms. Members of the House of Representatives serve two-year terms and are up every even-numbered year. State Question 632, passed in 1990, limits legislators to 12 years total service. However, it applies to legislators elected after January 1, 1991.


Each house considers four types of legislation: bills, which can become law if passed by both houses and signed by the Governor; joint resolutions, which have the force and effect of law when passed by both houses, but which may not become part of the statutes; concurrent resolutions, which express the will of both houses; and simple resolutions, which express the will of the house of origin. Legislation which originates in the Senate is numbered consecutively beginning with "1" and legislation which originates in the House is numbered consecutively beginning with "1001".

The Legislature occupies the second, third, fourth, and fifth floors of the State Capitol. Chambers for both houses are on the fourth floor, with visitors' galleries on the fifth floor. The telephone number for the Senate is: (405) 524-0126; for the House of Representatives: (405) 521-2711.

**Under certain conditions, failure of a measure will prohibit another bill having same effect and subject from being considered by the House during either session of the current Legislature.

***Final passage in the House normally requires 51 votes, 68 votes to adopt emergency clause. Vote requirement in the Senate is 25 votes, 33 votes to adopt emergency clause.

****Except during the last five days of session, the Governor has five days to take action on a bill. If no action is taken, the bill becomes law on its effective date.

*****No bill may become law after the final adjournment of the Legislature, unless signed by the Governor within 15 days after adjournment.
